

**ORDINANCE NO. 01-2015(A-3)**  
**Village of Elizabeth**  
**ELIZABETH, LOUISIANA**

An Amendment to Ordinance 01-2015 (A-2) of the Village of Elizabeth  
To Amend the Clerk Salary by increase and to Provide for Related Matters

**BE IT ORDAINED**, by the Mayor and the Board of Aldermen of the Village of Elizabeth, Louisiana, that the Code of Ordinance, Village of Elizabeth, is hereby enacting Amendment to Ordinance No. 01-2015 (A-2) of the Code of Ordinances, which shall read as follows:

**SECTION 1: BE IT ORDAINED**, that Ordinance 01-2015 (A-2) is hereby amended with regard to the salary paid to the Village Clerk. Said salary shall be increased, from \$2950 to \$3100, effective August 7, 2019, as follows:

<b>Clerk:</b>	monthly gross of \$3100
<b>Fire Chief:</b>	monthly gross of \$500
<b>Assistant Fire Chief:</b>	monthly gross of \$150
<b>Alderman:</b>	monthly gross of \$125
<b>Mayor:</b>	monthly gross of \$1600

**SECTION 2: BE IT FURTHER ORDAINED** that this ordinance shall become effective August 7, 2019, upon signature of the Mayor; or, if not signed or vetoed by the Mayor, upon expiration of the time for ordinances to become law without signature by the Mayor.

**SECTION 3: BE IT FURTHER ORDAINED** that if any provision or item of this ordinance of the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications of this ordinance which can be given effect without the invalid provisions, items, or applications, and to this end the provisions of this ordinance are hereby declared severable.

**SECTION 4: BE IT FINALLY ORDAINED** that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

**THIS AMENDMENT TO ORDINANCE 01-2015 (A-2)** was introduced on the 2nd day of July, 2019. **NOTICE OF INTENT FOR AMENDMENT** posted in the Official Journal on the 11<sup>th</sup> day of July, 2019.

**PUBLIC HEARING** prior to Adoption of amendment to Ordinance No. 01-2015 (A-2) to become Ordinance No.01-2015(A-3) held on August 6, 2019.

The above and foregoing Ordinance 01-2015(A-3) was read and called for a vote by the Mayor at a meeting of the Board of Aldermen called for said purpose on the 6th day of August, 2019. Motion was made by Ken Kelly and seconded by Angela Smith to adopt said amendment to Ordinance.
