

Ordinance No: 06-17B

Refer to Minutes 10-16-17; 9-22-20;12.1.20

**AN ORDINANCE TO SET UTILITY DEPOSIT AND TAP FEES FOR THE VILLAGE OF ELIZABETH,
LOUISIANA UTILITY CUSTOMERS AND TO PROVIDE FOR RELATED MATTER.**

BE IT ORDAINED, by the Mayor and the Board of Aldermen of Elizabeth, Louisiana that Ordinance No. 06-17B is hereby enacted to read as follows:

SECTION 1: BE IT ORDAINED by the Board of Alderman and Mayor of the Village of Elizabeth, Louisiana in special session convened, that the Board of Alderman and Mayor hereby amended Ordinance No. 06-17A to become Ordinance 06-17B for the Village of Elizabeth required utility deposit and tap fee for new utility services.

SECTION 2: BE IT FURTHER ORDAINED that the water, sewer and gas deposit of the Village of Elizabeth utility system are to be charged before services are connected as shown in section below unless prior arrangements have been approved by Mayor.

CONNECT SERVICES

Residential:

- Water Deposit: **\$150** plus **\$25** connect Fee = **\$175**
- Gas Deposit: **\$175** plus **\$25** connect Fee = **\$200**
- Water and Gas Deposit = **\$325** plus connect Fees = **\$375**

Commercial

- Water Deposit: **\$175** plus **\$25** connect Fee = **\$200**
- Gas Deposit: **\$200** plus **\$25** connect Fee = **\$225**
- Water and Gas Deposit = **\$375** plus connect Fees = **\$425**

Section 3: BE IT FURTHER ORDAINED that the water, sewer and gas tap fee for the Village of Elizabeth utility system are to be charged before services are connected as shown in section below unless prior arrangements have been approved by Mayor. Prices are for flat ground installation. Large ditches, road bores, excess flow valves and any work or materials outside the normal scope of work can cost extra and is not included in Tap and Deposit Fees.

TAP COST FOR NEW SERVICES

Residential:

- Install Sewer Tap: Fee \$300
- Install New Water Tap (¾" Meter): Fee \$175 plus Deposit \$150 = \$325 plus Connect Fee
- Install Gas Tap: Fee \$250 plus Deposit \$175 = \$425 plus Connect Fee

Commercial:

- Install Sewer Tap: Tap Fee \$400
- Install Water Tap (1" Meter or larger): Fee \$200 plus Deposit \$175 = \$375 plus connect fee
- Install New Gas Tap: Tap Fee \$300 plus Deposit \$200 = \$500 plus connect fee

SECTION 4: BE IT ORDAINED that this ordinance shall become effective December 10, 2020 and if any provision or items of this ordinance or the application thereof is held invalid, such invalidity shall not affect other provisions, items, or application of this ordinance which can be given effect without the invalid provision, items, or application and to this end the provisions of this ordinance are hereby declared severable.

SECTION 5: BE IT ORDAINED that all ordinance or part of ordinance in conflict herewith are hereby repealed.

THIS ORDINANCE was introduced on the 10th day of November 2020. After Public Hearing having been held on December 1, 2020, title having been read and Ordinance considered, on motion by Kelly Stalsby and seconded by Angela Smith to adopt said Ordinance 06-17B, a record vote was taken and the following result was had: Angela Smith: Yea Ken Kelly: Yea Kelly Stalsby: Yea
