AN ORDINANCE TO ENACT AN INCREASE IN SALARY FOR THE VILLAGE OF ELIZABETH CHIEF OF POLICE AND TO PROVIDE FOR RELATED MATTERS

BE IT ORDAINED by the Mayor and Board of Alderman for the Village of Elizabeth, Louisiana, who met in regular session and enacted the following Ordinance Number 15-19 which shall read as follows:

Section 1

There shall be an increase in the rate of pay for the Police Chief for the Village of Elizabeth as defined herein.

Section 2

The rate of pay for the full time Police Chief for the Village of Elizabeth is hereby set at \$3,200.00 per month. This pay is in addition to the \$500.00 State Supplemental Pay monthly.

Section 3

Any discrepancy in pay between the rate established in Ordinance Number 03-2015 and the actual amount paid to the Police Chief between the period of April 6, 2016 and the time of the January 8, 2019 is deemed to have been earned by the Police Chief and paid to him based on *quantum meruit*.

Section 4

For the term of office subsequent to the passing of this Ordinance, the position of Chief of Police for the Village of Elizabeth shall be a part-time position and the rate of pay for the position shall be \$2,700.00 per month.

Section 5

This ordinance shall become effective upon signature by the Mayor, or in the event of a veto, upon override.

Section 6

If any provision of this Ordinance and the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications of this Ordinance which can be given effect without the invalid provisions, items, or applications, and to this end, the provisions of this Ordinance are hereby declared severable.

Section 7

All ordinance or parts of ordinances in conflict herewith are hereby repealed to the extent that they conflict with this Ordinance.

Said Ordinance having been introduced on the 3rd day of March, 2020 by notice of Public Hearing having been published on the 12th day of March, 2020, said Public Hearing having been held, title having been read and Ordinance considered the 5th day of May, on motion by Kelly Stalsby and seconded by Angela Smith to adopt the Ordinance.
