

**Ordinance Number: 26-20**

**See October 6,2020 Minutes**

**AN ORDINANCE TO CHANGE THE DATE, TIME AND PLACE FOR THE REGULAR MONTHLY MEETING OF THE MAYOR AND BOARD OF ALDERMEN OF THE VILLAGE OF ELIZABETH, LOUISIANA.**

**BE IT ORDAINED** by the Mayor and Board of Aldermen for the Village of Elizabeth, Louisiana, who met in regular session and enacted the following **Ordinance Number 26-20** which shall read as follows:

**Section 1**

The regular meeting of the Mayor and Board of Aldermen of the Village of Elizabeth shall be held on the First Tuesday of each month at the hour of 6:00 p.m. at the Elizabeth Community Center located at 210 East Main Street, Elizabeth, LA.

**Section 2**

Be it further ordained that all ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent the conflict with this Ordinance.

**Section 3**

This ordinance shall become effective upon signature by the Mayor, or in the event of a veto, upon override.

**Section 4**

If any provision of this Ordinance and the application thereof is held invalid, such invalidity shall not affect other provisions, items, or applications of this Ordinance which can be given effect without the invalid provisions, items, or applications, and to this end, the provisions of this Ordinance are hereby declared severable.

Said Ordinance was introduced on the 22nd day of September, 2020. After Public Hearing having been held, title having been read and Ordinance considered, on motion by Ken Kelly and seconded by Kelly Stalsby to adopt the Ordinance, a record vote was taken and the following result was had:
