**AN ORDINANCE ADOPTING THE AMENDED BUDGET FOR THE
VILLAGE OF ELIZABETH, LA FOR THE FY 2020-2021**

WHEREAS, the Village of Elizabeth, LA has completed an amended General budget placed on file with the Village Clerk with the estimate of the amount of monies required to meet the public expenses, , reserve funds, and expenses of government of the Village of Elizabeth for the fiscal year ending June 30, 2021; and

WHEREAS, a notice was published that the board of Aldermen would meet on May 10, 2021 at 5:30 p.m., in the official meeting room of the Village Community Center for the purpose of making and adopting an amended budget for the fiscal year ending June 30, 2021, , and giving taxpayers within the limits of the Village an opportunity to be heard in a public hearing upon said budgets; and

WHEREAS, the amended general budget does not exceed the lawful limit of taxation allowed by law to be levied on the property within the Village for the purposes set forth in the budget, estimated expenditures set forth in the budget are all necessary to carry on the governmental activities of the Village for the fiscal year 2020 and 2021 and are sufficient to meet the various needs of the Village during that period;

NOW THEREFORE, the Board of Aldermen of the Village of Elizabeth, do ordain as follows:


